This year we will be using online tools including (but not limited to) Google Classroom, ZOOM, Remind App, Instagram, Mentimeter, and Padlet for virtual engagement with children, college students, and community members. This permission form describes the tools and student responsibilities for using these virtual tools.

As with any community-based effort, a strong relationship with families is needed for a successful experience. Whittier College CEC staff and students will work with your family to ensure we offer your child as much support as possible while following strict confidentiality and privacy guidelines.

The CEC has taken these steps in order to be in compliance with federal legislation for child protection, including The Family Educational Rights and Privacy Act (FERPA - <https://www2.ed.gov/policy/gen/guid/fpco/ferpa/index.html>) and the Children's Online Privacy Protection Act (COPPA - <https://www.ftc.gov/enforcement/rules/rulemaking-regulatory-reform-proceedings/childrens-online-privacy-protection-rule>).

Since the program workshops are web-based, content accessed from home or elsewhere outside the school or the Whittier College campus could put the student in contact with objectionable materials via the World Wide Web.
